



## McCurdy Youth Program 2024/2025

### Terms and Conditions Agreement

This Agreement ("**Agreement**") is entered into between McCurdy Bowling Centre ("**Centre**") and the undersigned youth bowler ("**Bowler**") for the period from September 14, 2024, to March 31, 2025.

#### Offer:

1. Centre will not charge regular weekly league dues for all youth Bowlers participating in the YBC program during the specified period. Tournament fees are not included in this offer. Shoe Rentals (\$3) are not included in this offer.
2. All Bowlers will receive a discounted practice rate of \$5 per session every Tuesday within Agreement period from 4:00pm to 5:30pm. Shoe Rentals (\$3) are not included in this offer.
3. Scheduled league dates are every Saturday morning. League play commences at 9:30am. Bowler will bowl 3 games each scheduled date.
4. Bowler has the option to purchase a youth uniform but is not mandatory.
  - 4.1 Youth uniforms are required to bowl in any provincial tournament.
5. Program is open to a maximum of 88 Bowlers between the ages of 6 and 21 (Based on birth dates after August 1<sup>st</sup>, 2002).

- 5.1 First 88 Bowlers that have paid registration and chocolate prepayments upfront will be accepted to the Program in that order.
- 5.2 Bowlers exceeding the maximum will be placed on waitlist.

**Terms:**

1. Bowler agrees to participate in the YBC program for the entire duration of Agreement period.
  - 1.1 Bowler further agrees to participate in a minimum of 80% of the scheduled league dates during Agreement period.
  - 1.2 If unable to attend a regular league date, Bowler is able to pre-bowl for that date and scores will be taken and used for the date missed.
    - (a) Pre-bowls will be counted towards the participation percentage based on the discretion of Centre.
    - (b) Pre-bowls must be booked in advance.
      - (i) Pre-bowl times are available throughout the week with the exemptions of Fridays and Saturdays after 5pm.
  - 1.3 If Bowler is unable to attend a regular league date and pre-bowl for missed date, communication to League Coordinator from parent of Bowler or from Bowler themselves with valid reasoning will be required to excuse absences.
2. Each Bowler's family is responsible to pay for all BCTF and YBC fees within 2 weeks of receiving an invoice. (Invoice will be sent out approximately middle of August).
  - 2.1 Approximate fees for registration to both programs is \$62 in total. (Approximate pricing is subject to change and based on BCTF and BowlBC's conditions.)
  - 2.2 Bowler must participate in a YBC chocolate fundraiser that requires Bowler to prepay for 1 case of chocolates that includes 30 boxes of chocolate. Each box of chocolate is valued at \$5. Each case is valued at \$150. All chocolates may be sold publicly, and/or kept by Bowler for compensation of prepayment.

**Breach of Agreement:**

1. If Bowler is missing for three weeks consecutively or breaches **Term 1.1** without a pre-bowled score or valid reason, Bowler will forfeit their spot on their team and in the Program. The next Bowler on waitlist will replace Bowler that is currently inactive.
  
2. Any fees unpaid by the registration deadline, as listed in **Term 2**, will result in Bowler's spot being reassigned to next Bowler on waitlist.
  
3. No refund of chocolates or registrations will occur after the start of the season if:
  - 3.1 Bowler chooses to withdraw from the program.
  - 3.2 Bowler does not meet conditions set in **Term 1** of Agreement.
  
4. Centre reserves the right to remove any Bowler from the Program at Centre's discretion. Payments of chocolates or registrations will not be refunded under this discretion.
